OCCUPATIONAL HEALTH AND SAFETY POLICY

It also aims to mitigate all types of hazards with minimal harm and to eliminate unavoidable risks using the best-known technical methods, ensuring no harm comes to employees, facilities, or the environment.

Within the company, the duties, authorities, and responsibilities of all personnel regarding occupational health and safety have been clearly defined and communicated to all relevant parties. All necessary resources will be mobilized to ensure that employees use personal protective equipment properly. In addition, regular training, drills, and awareness programs will be conducted to foster a sense of responsibility among all employees. Emergency risks will be evaluated through planning and practical exercises to identify and implement effective methods for protecting worker health.

Onsa Refinery Inc. has established and documented a Management System that fulfills the requirements set forth in the OHSAS 18001 Occupational Health and Safety Management System Standard, ensuring the implementation, maintenance, and communication of occupational health and safety policies and objectives to all employees.

To ensure the continuity, protection, and sustainability of the established system and preventive measures—and to objectively demonstrate that the system is adequately and effectively implemented in accordance with the TS 18001 standard—internal audits will be conducted, performance will be measured, and the results will be reviewed and evaluated by senior management.
